I John Harris of the Town Gut in the County of
Pictou, and Province of Nova Scotia, Farmer,
enjoying health of body and soundness of mind -
thank God for the same, do hereby make and
publish this my last will and testament, hereby
revoking any and all former will or wills made
by me. I will and bequeath to my son Hugh
Harris, the whole of my real estate situate at
Town Gut aforesaid and on which I now reside
together with Houses, Barns and improvements,
and also the whole of my stock of Cattle Horses Sheep,
farming utensils debts credits and effects, money
or other property of what soever kind. For my
wife Elizabeth I will bequeath and ordain, that
my said son Hugh Harris shall well and truly
pay to ^{my} said wife Elizabeth the sum of eighty dollars
per year, ~~that~~ and every year during her life time,
and also the use of the two best rooms in my said
dwelling house at Town Gut aforesaid, and the one
half part of the furniture and bedding of said
House. To have and to hold to the said Hugh
Harris, and his heirs and assigns for ever, the whole
of the real estate and personal property, hereinbefore
mentioned. And I do by these presents hereby
nominate and appoint George S. Harris of Pictou in
the County of Pictou, Deputy Sheriff - and the said
Hugh Harris - to be the executors of this my last will
and testament and trust that they will see the
same carried out in good faith.
