I Hugh Holmes Considering the  
uncertainty of this mortal life and  
being of sound and disposing mind  
and memory do make and publish  
this my last will and Testament  
in manner and form following  
that is to say

1<sup>st</sup> I give and devise to my daughter  
Annabell Cameron widow of the  
late John Cameron of Haddons

on which I reside bounded on
