I hereby give devise and bequeath to my beloved wife Catherine Saugill all my estate both Real and Personal whatsoever and wheresoever and of what nature and quality soever; To Have and To Hold the same unto her, for her use and maintenance her life time, if she remains unmarried but if she marry then she shall no longer use the same.

And at the death or marriage of my said wife, I do hereby give devise and bequeath unto my son J. B. Fraser Saugill the western part or portion of the lot of land whereon I now reside, that is the part on the western side of the Mountain road, so called, and also the Southern one half of the Dean and Chapter lot. To Have and To Hold the same unto the said J. B. Fraser Saugill his heirs and assigns for ever.

And at the death or marriage of my said wife, I do hereby give devise and bequeath unto my son Charles Saugill the Eastern part or portion of the lot of land whereon I now reside - that is - the part on the eastern side of the Mountain road so called. And also the Northern one half of the Dean and Chapter lot. And in regard to any personal estate or property not hereinbefore bequeathed - I give the same unto my said two sons J. B. Fraser and Charles to be equally divided between them.

I do hereby nominate and appoint George Gordon of River John merchant, the Guardian of my said infant sons J. B. Fraser and Charles -

And Lastly, I do hereby nominate and
appoint the said George Gordon the sole executor
of this my last will and testament.
