I give devise and bequeath to Thomas
Walker all the land and estate owned by me
lying and situate between the West River
Road and the West River to have hold
and enjoy to the said Thomas Walker
his heirs and assigns forever and also
the use of the Blacksmith Shop and
tools contained therein during the
term of the natural life of my beloved
wife Nancy

I give devise and bequeath to my
beloved wife Nancy all the residue of
my real estate personal property and my
estate and intend therein to have hold
and enjoy to my said wife Nancy
during the term of her natural life
and at the death of my said wife Nancy
all the said real estate and personal
property except what may have been
used by her for her own comfort and
wellfare shall be come the property of
the said Thomas Walker and his heirs
provided that the said Thomas Walker
shall continue upon
and work the said property as he should
I should the said Thomas Walker fail
to comply with the above conditions
to the satisfaction of my executors

hereinbefore mentioned than my said wife
Mary shall have full power to dispose
of the said residue of real estate and
personal property and employ the
proceeds for her own support and benefit
or for any other purpose which she shall
see fit or proper

I revoke and declare to be null
and void all other former wills by me or
any other heretofore made

I appoint my said wife Mary
and James Strain of Pictou Municipality
executors and administrators of this my
last will and testament to which I
have subscribed my name this seventh
day of April in the year of our Lord
one thousand eight hundred and ninety
seven
