I, Alexander M. Cullloch of Blue Mountain in the County of Fictou, and Province of Nova Scotia being of sound and disposing mind, memory, and understanding, and knowing that it is appointed to all men to die, do make and ordain this my last will and Testament, hereby revoking all former wills and dispositions heretofore made by me at any time.

First. I resign my soul into the hands of Almighty God and my body I commit to the earth to be decently interred at the discretion of my executors hereinafter named.

Second, I order that all my outstanding debts, and my funeral expenses be paid.

Third, I give and devise to my son James W. M^r Cullloch all the real Estate I am possessed of at Middlefield, said Real Estate being a lot of land adjoining the lands conveyed by me on a former occasion by Deed, to the said James W. M^r Cullloch.

Fourth. It is further my will that my wife Christy be residuary legatee to all remaining property, Real or personal, and also all money deposited in Banks or otherwise, and all goods, and Chattels, or whatever I may be possessed of at the time of my death.

Lastly, I name and constitute my daughter Mary, the wife of John B. Hingley to be my Executrix.
