To Foreign Missions Fund of the Presbyterian Church of Canada the sum of sixty Dollars.

To Home Missions Fund of above named Church the sum of fifty Dollars.

To French Evangelization Fund of above named Church the sum of Twenty dollars.

To Deaf and dumb institution of Halifax, Province of Nova Scotia the sum of Ten dollars.

To Bible Society the sum of Ten dollars.

I hereby nominate and appoint as Executors to this my last Will and Testament Andrew Fraser and Charles McDougall both of Garden of Eden, County of Pictou and Province of Nova Scotia.
