under the following consideration namely That the

Gregor shall at all times after my decease well
and truly provide the said Sarah M^c Gregor my
sister with comfortable Boarding and Lodging
and all other common necessaries of life
during the term of her natural life.

Third. I hereby nominate and appoint
the said Daniel M^c Gregor, the said Sarah
M^c Gregor's son to be my sole Executor of this
my last Will and Testament.

seal this Twelfth day of December in the year

of Our Lord, one thousand eight hundred and
Seventyfour.
