Know all men by these presents that I, Duncan
M^cGregor of Chance Harbor in the County of Pitou,
Farmer, taking into consideration the uncertainty
of life and being desirous to settle my worldly affairs
being of sound mind and memory. Do hereby make
and publish this to be my last will and testament,

I give devise and bequeath unto my
wife Lizzie M^cGregor all my personal property -
(except my eight day clock hereinafter to be
disposed of) Consisting of live stock, farming
utensils or whatever personal property may be
owned by me at the time of my decease including
money due by note of hand or otherwise, To the
sole and absolute use of her the said Lizzie M^c
M^cGregor and her heirs and assigns, together
with the free and undisturbed possession of
all the Real estate owned by me at Chance
Harbor in County aforesaid, and the free right
to use the same as she may consider best for her
maintenance during her lifetime also the use
of the eight day clock hereinafore mentioned until
the time of her decease.

I give devise and bequeath
unto my nephew Edward M^cGregor son of my sister
Sarah M^cGregor all the Real Estate owned by
me at Chance Harbor aforesaid, that is to say,
after the decease of my wife the said Lizzie
M^cGregor. To Have and to hold the same together
with the eight day clock hereinafore mentioned,
To him the said Edward M^cGregor and his
heirs and assigns.

I give devise and bequeath
unto my nephew Daniel M^cGregor son of my
sister Sarah M^cGregor the sum of Fifty dollars
the same to be a charge against my Real Estate,

unless the said Edward M^r. Gregor shall pay
the to him the same.

I order and it is my will
that my lawful debts and funeral expenses
be paid by my Executor out of my Real Estate
unless the said Edward M^r. Gregor shall pay
the same.

And lastly I do hereby nominate
and appoint Daniel M^r. Gregor hereinbefore
mentioned to be sole Executor of this my last-
will and Testament.

June in the year of our Lord one thousand
eight hundred and eighty four.
