I Alexander M^r. Jones of Scotch Hill, County of Victoria, Province of Nova Scotia, being full of body, but of perfect mind and memory, thanks be given to God, calling unto mind the mortality of my body, and knowing that it is appointed for all men once to die, do make and ordain this my last Will and testament, that is to say, principally and first of all, I give and recommend my soul into the hand of Almighty God, that gave it, and my body I recommend to the earth, to be buried in decent Christian burial at the discretion of my executors, nothing doubting but at the general resurrection, I shall receive the same again by the mighty power of God. And as touching such worldly estate wherewith it hath pleased God to bless me, in this life, I give, devise, and dispose of the same in the following manner and form,

First, I give and bequeath to John Angus M^r. Jones, my dearly beloved Son, all my lands, buildings, farm implements, whole stocks, monies and debts to be by him possessed and for his sole use for ever.

I give and bequeath to my beloved daughter Christie M^r. Jones a competent home, on this my present dwelling place, provided that she remains unmarried, if she is married she shall be free from the home, provided in this Instrument but shall receive the Fifty dollars current money at the day of my death.

I likewise constitute make and ordain Peter Fraser Hardwood Hill, and Peter M^r. Jones, Scotch Hill my sole executors of this last Will and Testament, and I do hereby utterly disallow, revoke, and disannul all and every other former testaments, Wills, legacies, bequests, and executors by me in any wise before named, made and

bequeathed, ratifying and confirming this
and no other, to be my last Will & Testament.

and ninety six.
