that I Robert de Jorloch of Eden of
Eden, County of Pictou and Province
of Nova Scotia do make and publish
this my last will and testament
First my will is that all my just
debts be paid by my executors herein-
after named.

Second I demand bequeath to my
son William de Jorloch of Eden
of Eden County and Province of Nova
Scotia the following of which I am seized
and possessed at this date
that is to say,

The lot of land I occupy being
in the Garden of Eden, County of Pictou
and Province of Nova Scotia bounded
and described as follows, on the
north by land owned by First my
de Jorloch, on the west by land
owned by John Julliland on the
south by land owned by A. M. Cameron
and on the east by Crown land
also all moveable property and
stock now on the place all furniture
and household articles to come into
his possession at my death and at
death of my wife Catherine
de Jorloch.

Also that I and my wife
above mentioned be in possession
of half of the house and woods
for during the remainder of
our lives
Thus I devise and bequeath to my

John Callum the Justice of Gordon
of Eden County and Province of Virginia
that after my death the sum of one
hundred Dollars be paid to her by
my executor

Fourth that after all expenses and
debts bequeath paid the remainder
of my money is to be paid to my
son William the Justice of peace
above mentioned

Also that the funeral expenses of

the Justice is to be borne by my son
William the Justice of peace
above named

I hereby recommend and approve
as executors to this my last will
and testament Alex J. the Justice
and John J. the Justice both of
Gordon of Eden, County of Prince
and Province of New Scotland
all former wills are null and
void
