I give and bequeath to my daughters Marion Jane, and Elsie Coull, each an equal share of my estate. But the share of Marion Jane and Elsie Coull shall be double the share each, of each of the first named of my daughters.

I order that all lawful demands against my estate form a first charge.

I hereby constitute and appoint George Douglas of New Glasgow Merchant and Mary Elisabeth Rose my daughter, severally Executor and Executrix of this my last Will and Testament.
