Pictou, Province of Nova Scotia Farmer, knowing
that it is appointed unto all men once to die,
and the uncertainty of life do make public and
declare this to be my last Will and testament,
that is to say in the first place I give and bequeath
unto my son Robert the sum of fifty Dollars (\$50)
to my Daughter Elizabeth I give and bequeath
the sum of one Dollar (\$1) to my son James I give
and bequeath my homestead the Farm on which
I now reside situate on Green Hill aforesaid,
Together with all the farming implements Stock
household furniture and furnishings, houses
outhouses barns goods Chattels and effects what
soever, on Condition that he my said son James
do pay as soon as convenient after my decease
or cause to be paid unto my son Robert and my
daughter Elizabeth the bequests first before
written unto my son Robert and daughter Elizabeth
respectively, and lastly, I nominate and appoint
Isaac M. Deau and Lawrence Millar to be
Executors under this my last Will and Testament
declaring all others to be void and this to be my last
Will and Testament. Dated at Green Hill this
twenty seventh day of February in the year of our Lord,
one thousand eight hundred and eighty three,
