shall be null and void. Secondly I  
will and bequeath to my nephews James  
W. Keiper of business Scotland one hundred  
and seventy five Dollars and to each  
of my nieces Ellen W. Keiper of Applescross  
and Mary W. Keiper near Inverness  
one hundred and seventy five Dollars  
and to my niece Jessie W. Keiper of  
Gardoch two hundred dollars and in  
the event of any of them persons James  
W. Keiper Ellen W. Keiper Mary  
W. Keiper or Jessie W. Keiper being  
dead when my executor is proposed  
to pay the said bequest then the  
amount bequeathed to such person  
or persons deceased shall not be paid  
but shall be and become part of  
the residue of my estate  
I will and bequeath to my grand  
niece Jessie W. Keiper of Applescross  
as executrix for her sisters legate

Myself and two hundred Dollars  
to be equally divided between myself  
and mine but if the said Jesse  
with Keefe shall not be living when  
my executor shall be prepared to pay  
this legacy, then this legacy shall  
not be paid but shall be and  
be the part of the residue of my  
estate.

I will and bequeath to Jesse  
with Keefe within of George with Keefe  
of four hundred and thirty Dollars  
I desire my executor to cause  
my name to be put on my instrument  
in the Southern Home Land and to  
pay all other necessary expenses

The residue of my estate I will  
and bequeath to my good nephew  
Pierce Keefe son of the country  
on condition that he present no  
claim of any kind against my estate

I desire my executor to pay these  
legacies within a reasonable  
time of my death or his disinterment

I nominate and appoint James  
Fram of Southern Minister of the  
Gospel to be the executor of this  
my last will and testament
