1. I give devise and bequeath to my beloved daughter

bounded on Archimedes Street purchased by me from  
August Fraser late of Halifax Merchant.
2. I give devise and bequeath to my daughter  
Pessie the lot immediately to the rear of the  
aforementioned lot bounded on James Street  
purchased by me from William Forbes  
deceased.
3. I give devise and bequeath to my daughter Pessie  
the lot I own at the rear of the town of New Glasgow  
originally purchased from William Forbes of  
New Glasgow, deceased.
4. I give devise and bequeath to my daughter Mary  
the lot joining the last mentioned lot and  
which was purchased by me from William Forbes  
formerly of West River, deceased.
5. All my personal property of every kind, I give  
and bequeath to my said two daughters Mary  
and Pessie to be equally divided among them  
by my daughter Mary in such way as she  
shall deem best, giving the said personal  
property to them absolutely to be disposed of  
as they may see fit.
6. I appoint James W. Carmichael of New Glasgow  
Merchant and Duncan G. Fraser of the same  
place, Solicitor, sole executors of this my last  
Will and testament.
