I give devise and bequeath to  
my wife Mary Ann Marshall all  
my real estate and personal property  
consisting of a house and lot at  
West side New Glasgow described in  
a deed from Hugh Murray and  
others bearing date the thirty first  
day of May in the 9<sup>th</sup> year of our Lord  
one thousand eight hundred and  
eighty seven as follows namely  
beginning sixteen and a half feet  
from the Alton Mines Sir John  
railroad and at the north east  
angle or original boundary of  
a certain William Frazer (off)  
land from thence north eighty  
seven and a half degrees west  
ten rods to a stake and stone  
thence south two and a half  
degrees west nine rods or within  
sixteen and a half feet of the  
said Railroad thence north  
forty degrees east eleven rods or  
until it comes to the place of  
beginning containing one

quantity of an acre be the same  
more or less, Also all my  
personal property of whatever  
kind owned by me at New  
Gloucester as also then at the  
time of my decease

appoint my wife Mary Allen,  
Marshall & executor of this  
my last will and Testament
