also the lot of land or field owned by me
and situated on the West side of River
Street bounded and adjoining on the
North the Townsend property on which
I now reside known as the Patterson field
I give devise and bequeath to my
son John the after the lot of land or
field owned by me and situated on the
South side of the Old Road is called
leading from the Town of Putnam to the
Town of Gales and called also this lot
of land or field owned by me and situated
on the East side of the River leading
from the River Road to the back
Road of the Town of Putnam is called
also the lot of land and bequeath to
my son John the after the lot of land
situated on the West side of the
Township property on which I now
reside owned by me situated on the
West side of River Street adjoining
with the dwelling house and all
buildings thereon and all
therein, provided however that

my said son Thomas Weaghen shall leave
the use and occupation with free
possession and egress of the said
Houghton house and outbuildings
on the said lot and premises during
the term of his natural life.

I have given and bequeathed to my
said daughter Phoebe Weaghen all
the household furniture owned by me
and contained in my said dwelling
house.

I have given and bequeathed to my
said daughter Margaret H. La
Borde daughter of the said
John LaBorde the sum of five hundred
dollars.

I have bequeathed and given
my said son Thomas Weaghen and
Phoebe Weaghen executor of the will
of the said and testamentary
