my personal property, and all money and securities for money,  
which at the time of my decease shall belong to me.

I appoint my said daughter Maria Scott, my executrix  
of this will and devise.

I further declare that my not making any bequest to  
my other children is intentional and agreeable to their express-  
ed wishes.
