Second, I give devise and bequeath my Estate and Property real and personal as follows. that is to say.

First my Real Estate to be divided between my two sons James W. Senness and John Senness. James W. Senness to have the north half from Rear to front. John Senness to have the South part from Rear to front, personal effects as follows to each of my Daughters one Cow each, Catherine Grace and Ellen Ann, and also three sheep each the remainder of the cattle to be divided between James W. Senness and John Senness with the exception of one Cow which is to be for my wife Mary Senness. James W. Senness to have the young horse, and the Mowing Machine, and John the old one, In consideration of the above property I hereby will and desire that James W. Senness and John Senness my sons do keep and provide for their mother my wife, Boarding and lodging during the term of her natural life. I further will that James W. Senness, and John Senness my sons do provide and assist my son Robert until he arrives at the age of twenty one years when each of them will give him forty Dollars each.

I appoint Alex. J. McMay Farmer of Fox Brook in the County of Pictou, and John Cumming Farmer Executors of this my last Will and Testament.
