bequeath unto my beloved Wife Ann
With all the Monckale Stock and Farm-
ing utensils the whole to be by her possessed
till my Death With full Power to de-
vise bequeath or Deed the same
to all or any of my children as may
seem most prudent to her at any
time or to sell to any other person
provided that whatsoever she may be
possessed of at her Death may come
to all or any of my children as above

And I do by these presents nominate
Constitute and appoint Peter McDo-
nald D. Son to be my Executor of this
my Last Will and Testament revoking
hereby and making void all former
and other Wills by me made. In Witness
