McMay of River John and Kenneth Ross of Invermay both of the County of Pictou to be the executors of this my last Will and Testament, and I do hereby utterly disallow revoke and disannul all and every other former testament, Will, legacies, bequests, and executors by me in any wise before named, killed, and bequeathed, ratifying and confirming this and no other to be my last Will and Testament.
