I then I give devise and bequeath to

buildings thereon and all contained  
in them or belonging and appertaining  
to them, all my stock horses  
Cattle Sheep and Swine all my  
farming implements including Carts  
waggons Ploughs and harrows and  
the harness belonging to the same  
and all the cash which I may  
have on hand or deposited or

And lastly I do nominate  
and appoint my beloved wife Anne  
Sutherland executrix and I am to  
be paid by. Merchant of New  
Glendon executor both of Victoria  
County executor and executor of  
this my last will and Testament
