do hereby make and make known to  
you my dear friends and neighbors  
that it is appointed in for all men  
over to die do make and make known  
this my last will and testament that  
is to say principally and first of all  
I give and recommend my soul unto  
God who gave it and my body I re-  
commend to the earth to be buried in a decent  
Christian burial at the discretion of my  
dearly and affectionate daughter but  
at the general resurrection I shall re-  
ceive the same again by the Almighty Power  
of God and as touching such worldly  
estate wherewith it hath pleased God to  
bless me with in this life I give devise  
and dispose of the same in the following  
manner that is to say

First I give and bequeath to Robert Sutherland  
my beloved son all my lands, tenements, stocks, consistories,  
corn, cattle and sheep together with  
all the farming implements, subject  
to the following conditions and covenants  
to wit that my daughter Ann Sutherland  
and her husband or his heirs and assigns  
shall have a house or one third part of the  
place to include their cattle as with the  
manner

man and way as they had with me  
and from during my life time also that my  
said son Robert Inthelaud shall  
pay to my said daughters the sum of Forty  
Dollars per year each - said sum to be paid  
in installments of Eight Dollars each  
a year until the whole is paid. In the event

of ~~any~~ ~~of~~ ~~my~~ ~~decease~~ ~~or~~ ~~the~~ ~~decease~~ ~~of~~ ~~my~~ ~~said~~ ~~son~~ ~~Robert~~ ~~Inthelaud~~  
the place and share by marriage their  
linen and clothing as abovesaid shall  
be as and the Cash bequest to be paid in full  
on the occasion of one of all of them having  
the place by marriage.

I hereby ordain that my said son Robert  
Inthelaud shall & lawfully enjoy & possess  
all the property I own & possess as  
heretofore stated (peaceably & without let or  
hindrance) & whatever from any person  
or persons lawfully claiming the  
same subject to the conditions herein  
specified.

And I do hereby utterly disallow  
revoke & annul all former wills or  
wills or testament bequest or  
executions by me or any other person named  
or to be named in any of the said  
wills or testaments or other bequest or  
executions.

I hereby nominate and  
appoint Mr. John Inthelaud of New York and  
my said son Robert Inthelaud as joint  
executors of my last will and  
testament.
