

This is the last Will and Testament
of one William Sutherland of Carriboo Harbour in
the County of Pictou. N. S.

First I give devise to my beloved wife the
one half of the Farm that I now reside on con-
-taining fifty acres more or less, being the east
side of my said farm running from front or
shore at said Carriboo Harbour along the land of
Alexander Sutherland till the rear of my said
farm to have and to hold the same during her
natural life, also the use of two rooms on the
West-side of my House, also the use of one Cow
and six Sheep;

Second, I give devise and bequeaths to my eldest
son James Robert Sutherland the remaining half
of my farm containing fifty Acres more or less, to
have and to hold the same to him and his Heirs
forever, Also at the death of my beloved wife M^{rs}
Sutherland I give devise and bequeaths to my
said son James Robert Sutherland the half
bequeathed to my beloved wife, as aforesaid during
her natural life subject to the following conditions
That is to say that my said son James Robert
Sutherland will work the said fifty acres for
his mother and support her during her natural
life and and furnish her with suitable Fuel and
Supply of Provision for the use of the rest of my beloved
children, until they become of age to make a living
for themselves, To have and to hold the same to
him and his Heirs for ever.

Lastly I give and bequeaths James R.
Sutherland all my said farming Implements and
farm stock with all the residue of my property of what
so ever nature after the payment of my just debts
and Funeral expense—

And I nominate and appoint Daniel Munro and John R. Dobson Conj- executors of this my last Will and Testament hereby revoking all others and former wills.
