this Second day of July in the Year of our  
Lord one thousand eight hundred and forty nine  
between John Campbell Senr. of Merigonish farmer  
of the one part, and Barnibap Mac Rowen of  
said Merigonish and province of Nova Scotia farmer  
of the other part. Witnesseth that the said John  
Campbell Senr. for and in consideration of the sum  
Thirty seven pounds of current Money of the province  
afore said to him in hand paid at or before the  
making and delivery of these presents the receipt  
whereof is hereby acknowledged, hath granted bargained  
sold released remised and confirmed unto the said  
Barnibap Mac Rowen his Heirs and assigns.

All that certain Lot or piece of Land situate lying  
and being in the Governors Grant at Merigonish and  
described as follows viz Bounded on the North  
by the Lands of James Suggan, on the west by the  
Lands of James Shea, on the south by the Lands of  
James Cressar Esq. and lately in the possession of  
James Pollock, and on the East by Lands now in  
possession of John Campbell Junr., containing  
one hundred Acres more or less, To have and To hold  
the said described Lot of Land and all the Claim  
title interest and demand of him the said John  
Campbell Senr. in and to the same by virtue of a  
purchase from one James Shea or by virtue of  
of his own possession or otherwise. to Barnibap  
Mac Rowen his Heirs and assigns to his and their  
own proper use and behoof for ever. And the  
said John Campbell Senr. for himself his Heirs

and assigns by these presents, Doth Warrant and  
Defend to the said Barnabas Mac Kowen his  
Heirs and assigns, The Title to the before described  
Property either at Law or in Equity -
