I give and bequeath to my daughter

or to her children in event of her  
predeceasing me one feather bed, one  
bolster, two pillows and one hundred  
dollars lawful money of Canada.

I give and bequeath to my  
daughter Margaret Coover the sum of  
Ten hundred dollars lawful money  
of Canada and all my household  
furniture of whatsoever nature or  
description.

I direct my executors to pay  
all my just debts funeral and  
testamentary expenses as soon as  
conveniently may be after my decease.

I bequeath to my three sons  
William, James and David share  
and share alike all my ready  
money including money in the  
hands of my banker or agent.

subject to the above mentioned bequests  
and should any of them my Sons  
predecease me then said money shall  
be divided equally between the survivors

I direct my executors to sell and  
dispose of all my real estate as soon  
as may be after my decease and to  
divide the proceeds thereof and the acc-  
rued interest between my three Sons William,  
James and David or the survivors of  
them to whom I bequeath the money  
or moneys realized from such sale
