This is the last will and testament of Jane Forbes widow of the late Kenneth Forbes of New Glasgow in the County of Pictou and Province of Nova Scotia

I the said Jane Forbes do hereby constitute hereinafter named as soon after my death as convenient to sell and dispose of all my real estate and to convert the same into all personal property that I may be possessed of at the time of my death into cash, and having so done to dispose of my estate as follows

First To erect a joint tombstone to the memory of my late beloved husband Kenneth Forbes, my late sister Margaret-Ann Coumell and myself.

Second I give devise and bequeath the sum of fifty dollars to Jane Perrygo daughter of my niece Margaret Perrygo

Third. The residue of my estate after paying all my debts and funeral expenses and the expenses of settling my estate and the above bequest I give devise and

bequeath as follows, that is to say
one third each to my nieces Margaret
Perrigo, Annie Perrigo and Elizabeth
the Council (McKenzie) in each case
for her sole and separate use and
free from the control of them and each
of their husbands if any

I hereby empower my executor to sell
all my real estate and personal effects
at public auction or by private contract
using his discretion as to the price
to be obtained therefor and what so ever
debts good and sufficient due or due
thereof to the purchaser or purchasers
of the same

I appoint John H. Sullivan of New
Orleans Barrister at Law as the sole
executor of this my last will hereby
revoking all former wills by me at
any time heretofore made

I do witness whereof I the said
Jane Forbes have to this my last
will and Testament contained in this
and the preceding sheet of paper
set my hand and seal this fourth
day of April A.D. 1902
