This is the last Will and Testament of Alexander
Feaser of New Glasgow in the County of Pictou, Patter-
master,

I Alexander Feaser of New Glasgow in the
County of Pictou, Pattermaster being through the
blessing of God of sound mind and memory but
knowing that it is appointed that all shall die,
do make and ordain this as and for my Last
Will and testament,

I commit my soul to God
hoping for the forgiveness of all my sins through
the merits and mediation of my Lord and Saviour
Jesus Christ, and I order that my body be decently
buried by my Executors hereinafter named and
my worldly goods I dispose of as follows viz.

Firstly, I give and devise to my beloved wife
Catherine Ann all my Real Estate situate
and being in the town of New Glasgow on the west
side of the Cash River consisting of Forty four
acres, be the same more or less with all and
singular the Houses and other buildings with the
appurtenances to her sole use and benefit forever.

Secondly, I give and bequeath to my beloved wife
Catherine Ann as aforesaid all and singular my
personal property, Goods, Chattels, and effects of every
kind and description whatsoever to be disposed of
by her as she may see fit.

I nominate ordain and appoint
my said wife Catherine Ann as Executrix, and
my brother John Feaser of New Glasgow aforesaid
as Executor of this my last Will and testament,
and thus revoking all other Wills by me made.
