In the Name of God Amen,

I, Bessie Francis of M. Tolland's Brook in the County of
Penton and Province of Nova Scotia (Sprinkler) being
through the blessing of God in a sound state of mind
and memory and taking into account the uncertainty
of life and the certainty of death do make and ordain this
my last Will and testament in manner and form
following.

First, I Commit my Soul to God hoping for the forgive-
ness of all my sins through the merits and mediation of
my Lord and Saviour Jesus Christ.

Secondly, I order my body to be decently buried by my
Executors hereafter named and as to the worldly property
wherewith it has pleased God to bless me I dispose of
as follows:

And First, I give and bequeath to my dear friends
namely my beloved Sister, Rachel Gammell, my
beloved Sister Margaret Tupper and my Beloved
Niece Isabel Chipman each one fourth of my Money
now in the Halifax Savings Bank, the said money
to be paid to them by my executors within six months
after the death of my beloved husband Alexander
D. Francis (to whom I hereafter give and bequeath
the Interest of said money during his lifetime or
until his death.)

Second, I give and bequeath to my dear friends namely
my beloved nephew James W. Tupper, my beloved nephew
Edward S. Tupper and my beloved niece Mary Tupper,
each an equal share of the remaining one fourth
of my money now in the Halifax Savings Bank aforesaid,
the said money to be paid to them by my executors
within six months after the decease of my said dear
husband Alexander D. Francis.

Finally I give and bequeath to my Beloved

husband Alexander D. Fraser all and singular
my Real Estate situate lying and being on Mr. Lellan's
Book in the County of Pictou aforesaid.

I also further give and Bequeath to my said
beloved husband Alexander D. Fraser during the
term of his natural life or until his death the Interests
of my money now in the Halifax Savings Bank aforesaid.

And I hereby nominate and appoint
Stanley M. Curdy and Hugh G. Gammond to be Executors
of this my last Will and Testament hereby revoking
all former wills by me made and ratifying and
confirming this and no other to be my last Will and
testament.
