I bless Frazer of home in the
County of Pictou and Parishes of
Leona Scotia do make and declare
this my last will and testament
First I bequeath all my real and
personal estate excepting what is
hereafter mentioned to my beloved
son John Robert Frazer to hold and
to have power providing he maintains
my wife Catherine and Frazer that
is to say he the said John Robert
Frazer is to provide a house cloth
and food; also to carry her by
horse and carriage to and from church
also he the said John Robert Frazer
is to see her the said Catherine
and Frazer have the charge of the
herm now occupied by me, the said
that to be hers during her life at
her death to revert to John Robert
Frazer, John Robert Frazer is also
to give unto the said Catherine and
Frazer one milk cow and 3
sheep and he is to feed the same
for his mother during her life at
her death the same is to revert
unto the said John Robert Frazer
John Robert Frazer is also to give
unto his mother during her life
two mules or all notes of hand
and all interest on Bank deposits
held by me at my death to be
paid unto the said Catherine and
Frazer if early, I also bequeath
unto my beloved daughter Muffie
& Jean one cow and 6 sheep
on the value of same at my death

providing I do not give her the one
Cow and the 6 Sheep during my
life if I do it is understood that
she is not to receive the one Cow
and 6 Sheep or my death or if I
give her the value of the one Cow
and 6 Sheep during my life. Then
this bequest is null and void
John Robert Train is to pay all
funeral expenses and to erect a
suitable Monument and to pay all
expenses in connection with
providing this my last will and testament

I hereby nominate and appoint
as my life executor John Robert Train
of Lorne in the County of Pictou
Province of Nova Scotia and David
McLennan of Dalrymple in the County
of Pictou and Province of Nova Scotia.

Notwithstanding the clause in
this will and testament giving the
half of my house to Catherine Ann
Train, I hereby revoke that clause
and add the following in place of
John Robert Train being a part
of the north side of the house I hereby
give him possession of the same
after my death providing he desires
to build or add to it.
