In the name of God Amen,

I Donald Fraser of M. Tullain's Brook in the County of Pictou, and Province of Nova Scotia Farmer, being by the blessing of God of sound disposing mind and memory both taking into consideration the uncertainty of life and the certainty of death do make and publish and ordain this my last Will and testament in manner and form following.

First. I Commit my Soul to God trusting for the forgiveness of all my sins through the merits and mediation of my Lord and Saviour Jesus Christ, and my body I order to be decently buried by my Executor hereinafter named and my worldly goods and property I dispose of as follows.

Secondly. I give and devise to my son Abram G. Fraser all my leased and real Estate situate lying and being at M. Tullain's Brook in the County of Pictou and Province of Nova Scotia aforesaid, consisting of the farm lot with the appurtenances, on which I now reside to live and his heirs for ever.


Thirdly. I give and bequeath to my said son Abram G. Fraser all and singular my personal Estate, Goods, and Chattels, debts, credits and effects of every kind and description which I may own or possess at the time of my death to live and his heirs for ever.

Fourthly. I nominate, appoint, and ordain as and for Executor of this my last Will and Testament my son James G. Fraser of New Glasgow, and I now and hereby publicly pronounce, and declare this and no other to be my last Will and Testament, and thus revoking and cancelling

all other wills that may have by me been made,

of February in the year of our Lord one thousand
eight hundred and ninety one;
