I give devise and bequeath unto my
wife Alice Garwin of the Town and County
of Pictou all my real and personal property
of every kind and nature whatsoever and
wheresoever situate To have and To hold
the same to her for the term of her natural
life and after her death I give and devise
the same to my daughter Barbara Green
of Pictou aforesaid To have and To hold
the same to her, her heirs and assigns
forever free from the control of her husband
and with full power to sell and dispose
of said property without the consent of
her husband

I give devise and bequeath to my
daughter Anna Sorrel wife of Thomas
West of Seatter Washington Territory in
the United States the sum of two
hundred Dollars the same to be paid
within a reasonable time after the death
of my said wife

I give devise and bequeath to my
Grandson Henry Howard Garwin of Boston
in the United States Two hundred
and fifty dollars Canada money to be
paid within a reasonable time after
the death of my said wife

I give devise and bequeath to

my Son James Stewart-Garwin Master
Mariner now sailing out of New York
the sum of five dollars to be paid
within a reasonable time after the
death of my said wife

I order and direct my Executors
hereinafter named to pay all my debts

I hereby revoke all former wills
by me at any time heretofore made
and declare this to be my last will
and Testament

No interest is to be paid or
chargeable on the legacies herein
devised

I hereby nominate and appoint
my said wife Alexis Garwin and my
said daughter Barbara Beem and
the survivors of them Executors and
Administrators of this my last will and
Testament
