This is the last Will and Testament of  
one Rodrick's Crank of Carriboo in the County of  
Pictou - Farmer.

After payment of my just debts  
funeral and testamentary expenses I dispose of  
my Estate as follows -

I give devise and bequeath unto  
Sibby Seaward wife of Captain William Seaward  
of Pictou, in the County of Pictou, all that lot of land  
and premises owned by me situate on the East  
side of Elliot Street in the Town of Pictou whereon  
the said Sibby Seaward now resides. To Have and  
To Hold the same unto the said Sibby Seaward  
absolutely for her sole and separate use free  
from and independent of the debts of her present  
or any future husband and without being  
subject to his management or control.

I give devise and bequeath unto  
my daughter the said Sibby Seaward all my  
personal property and especially all monies  
which I have on deposit in any bank or banks  
whatsoever To Have and To Hold the same  
unto the said Sibby Seaward absolutely for her  
sole separate use and benefit free from and  
independent of the control and management  
of her present or any future husband and with-  
out being subject to his debts or engagements;  
and I hereby give unto said daughter the said  
Sibby Seaward the power to dispose by will as  
she may think fit of any or all of the foregoing  
real and personal property hereby so bequeathed  
to her.

And I hereby nominate and appoint  
the said Sibby Seaward sole Executrix of this.
