I give devise and bequeath my estate and property real and personal as follows that is to say to my son John William Gorm the Saw Mill and the yard about it used for lumber and all my books & accounts due or owing at the time of my decease for carrying;

To my daughter Mary Ann Gorm and Margaret Permet Gorm and my son Angus Sterling a comfortable living while they may choose to remain at home and when they may leave the house they are each to have if they desire one Cow. To my son Alexander Ross Gorm all the remainder of my property real and personal or mixed; The lands, the House, Barns & outbuildings, the stock, Horses, Cattle, Sheep, and Swine, The Carts, Waggon, and all the farming implements, after all the lawful debts I was or may owe at the date of my decease out of this estate above bequeathed.

I appoint William Ross Farmer, of Blue Mountains in the County of Pictou and Province of Nova Scotia and James Gorm of East River St. Mary's in the County and Province aforesaid, Executors of this my will.
